IV. COMPONENTS

Effective for applications taken on or after May 4, 2020, the attached income guidelines for determination of low-income status commonly referred to as the 70% Lower Living Standard Income Level (LLSIL), are to be used for determining eligibility.

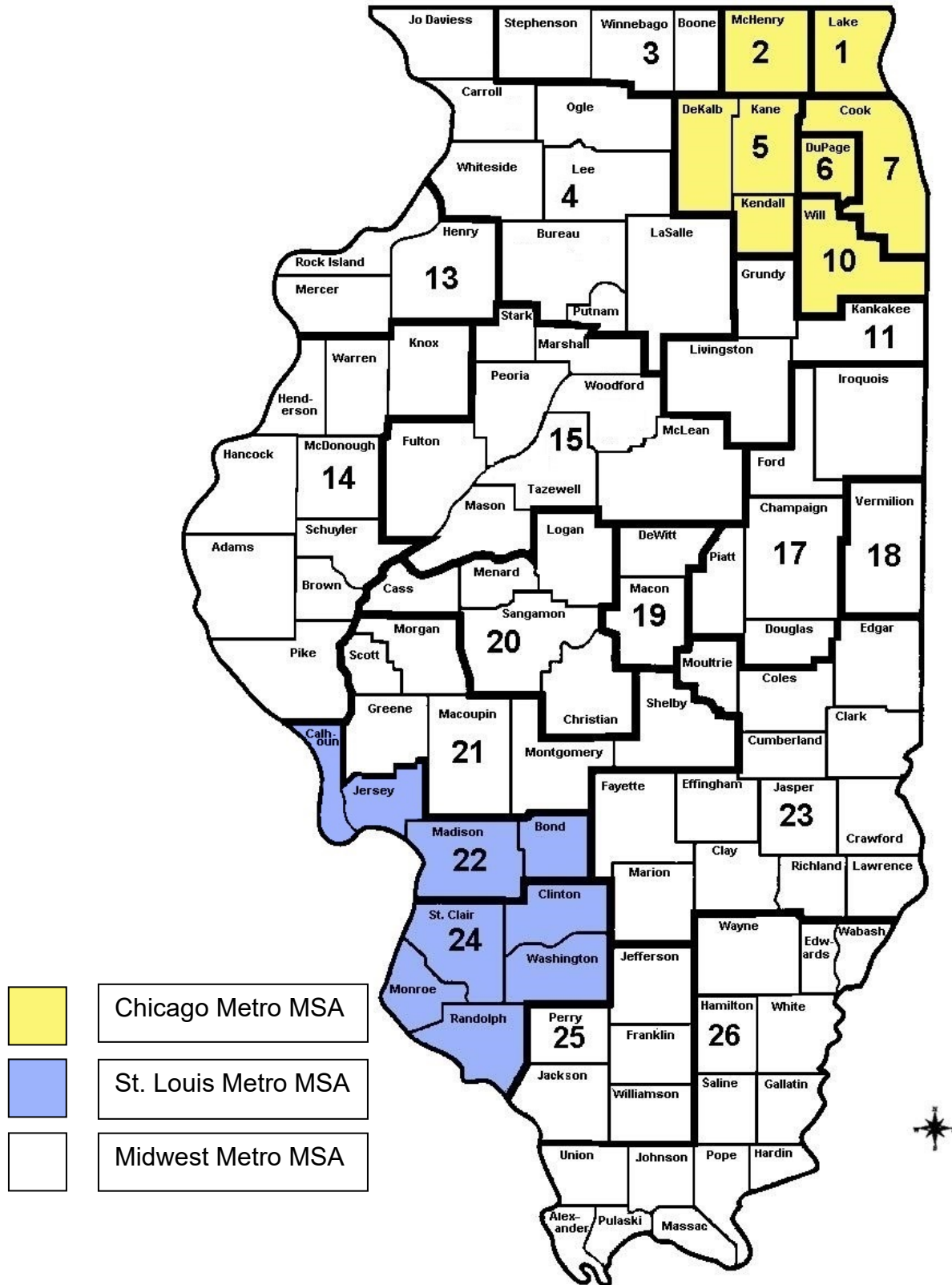
V. ACTION REQUIRED
