## PROPOSAL FOR WIOA YOUTH SERVICES IN BOONE AND WINNEBAGO COUNTIES (*Elevate-* Program) Program Year 2022 (7/1/22-6/30/23) (Title I-B of the Workforce Innovation and Opportunity Act)

- Does the program need to be run out of the One-Stop Operator location in Rockford, IL?
   Yes, the program does need to be run out of our main site at 303 N Main Street, Rockford, IL, however, there can be other locations in the community.
- 2. Page 4, Section 4 H. notes that profit be negotiated separately from the price. Should proposers include profit in their budget, or is this a separate process?

Yes, the profit should be included in the budget.

3. Since funding is estimated to total \$920,000, should the total budget be less than \$920,000 if a proposer wishes to request profit?

The total including profit should be \$920,000.

4. Does the proposer need to budget for any facilities costs at the existing three (3) locations in Rockford, Belvidere or Freeport listed on the cover page of the RFP?

Yes. Based on current staffing levels, that amount is \$60,000.

5. Is there a minimum amount that must be budgeted for work experience?

Yes, currently that amount is \$209,000 of the \$920,000, however there is some flexibility depending on the amount of money spent on OJTs.

6. Is the incumbent the employer of record, or are the direct employers that clients work at the employer of record?

The incumbent (subrecipient) is the employer of record for work experiences.

7. Do you have the funding allocation % between ISY and OSY for PY 2022?

Although the State of Illinois currently has a waiver which allows us to spend up to 50% of our funds on In-School Youth, our current split is 15%/85%. Since this waiver could end, we suggest planning for at least a 20/80 split unless there is a strong argument to do otherwise.

- 8. If you do not have the funding allocation between ISY and OSY for PY 2022, historically what have been the funding allocation % between ISY and OSY?
